MEMBERS AGREEMENT

WARNING: This is a legal document that affects your rights. Please read it carefully.

1. I acknowledge that competitive triathlon involves the real risk of serious injury or even death from various causes including overexertion, equipment failure, dehydration, accidents with other competitors, spectators or road users, course or weather conditions and other causes.
2. I understand that I should not compete in these events unless I have trained appropriately and a medical practitioner has verified my physical condition.
3. I understand that any information or training advice obtained through a Cairns Crocs Triathlon club member, unless otherwise stated, is not from a trained person with appropriate or any coaching qualifications. Any information or advice you receive should be discussed with a qualified coach and/or qualified medical practitioner prior to implementation. Participation in any group training activities publicised by the Cairns Crocs Triathlon Club including swim squads, running sessions, brick training, group bike rides or other group training is done at your own risk. You are not covered by the Cairns Crocs Triathlon Club insurance during any training sessions or group activities. The Cairns Crocs Triathlon Club or its members are not responsible for any damage, injury or loss which may occur to you or your property during any group activity. Triathlon Queensland can offer you some insurance cover and Cairns Crocs Triathlon Club recommends that you make your own enquiries direct with Triathlon Queensland.
4. By participating in club activities, I accept all risks necessarily flowing from my participation, which could result in loss of life or permanent injury. Accordingly, I release all persons or corporations associated directly or indirectly with the conduct of the event from all claims demands and proceedings arising out of my participation and I hereby indemnify them against all liability (including liability for their negligence and the negligence of others) for all injury, loss or damage arising out of or connected with my participation in these events. This release shall extend to and include ASC Sports, Triathlon Australia Inc., Triathlon Queensland Inc., Cairns Crocs Triathlon Club Inc, and their respective directors, partners, managers, officers, agents, contractors, employees and volunteers including medical and paramedical personnel appointed for the events, the owners, licensees and occupiers of land upon which the events or any part of it is conducted, any statutory body or local authority having control over any land upon which the event or any part of it is conducted or which is involved directly or indirectly with the events in any manner whatsoever and promoters, sponsors and event organisers. This release and indemnity continues forever and binds my heirs, executors, personal representatives and assigns.
5. I consent to receiving any medical treatment including ambulance transportation that the event organisers think desirable during or after the event.
6. I consent to event organisers using my name, image and likeness before, during or after the event for event promotional broadcasting or reporting purposes in any media.
7. I understand that compulsory insurance cover effected for participants in these events may not cover me for any or all injury, loss or damage sustained by me.
8. Safety precautions undertaken by organisers (such as course supervision, race safety briefings, bicycle and helmet safety checks) are a service to me and other competitors but are not a guarantee of safety.
9. I am fully responsible for the security of my personal possessions at the events.
10. My registration is not transferable to other people. If I am unable to compete, or if the event is cancelled by way of circumstances beyond the control of the event directors, my registration fee is non-refundable.
11. I have listed below my medical or physical conditions from which I suffer that might affect my performance or be relevant I accept the risk of participating, despite these conditions.
12. I agree to abide by all race rules and directions issued by Triathlon Australia and the event organiser.
13. Event organisers may change the event format, course or other race conditions at their discretion. If that occurs, this agreement applies to the changed conditions.
